# **RETURN POLICY - PARTS & ACCESSORIES**

To be eligible for a return, the item:

- Must be returned to the selling dealership within 30 days of receipt
- Must be in original condition (i.e., new and unused), and must be returned with all parts, components, instructions and in the original shipping container.
- Batteries, EV Chargers and Electrical Parts are not returnable.
  - EV charging adapters are returnable to the selling dealership within 30 days of receipt.
- All returns are subject to seller dealership inspection.

All returns will be refunded in the original purchase tender type. For more information on GM Rewards, visit their Terms and Conditions.

Sellers reserve the right to refuse the return of any parts that have been opened, unsealed, or used in any manner, or that do not meet the above criteria.

## CANCELLATIONS AND RETURNS – GM ENERGY HOME ENERGY PRODUCTS

You may request to cancel your order for GM Energy Home Energy Products at any time prior to shipment of those products by calling a GM Energy Home Energy Consultant at (833) 64POWER. Your GM Energy Home Energy Products order cannot be cancelled if the products have shipped. If you made a payment on a GM Energy Home Energy Products order before cancelling that order, you will receive a full refund on the payment card used to make the purchase within 30 days of GM Energy's acceptance of your cancellation request.

You may initiate a return of GM Energy Home Energy Products within 14 days following delivery, subject to the terms and conditions contained herein. # AUTOMOTIVE PARTS CORE CHARGE AND CORE CHARGE RETURN POLICY

Certain automotive parts can be recycled and remanufactured for future use. These parts have a "core charge" that is used as a deposit on the portion of the part that can be reused. The reason for this charge is to encourage the return of your old part. When the recyclable component from your old part is returned to us, the charge is refunded to you. To receive your core charge refund:

If you picked up the part from the Dealer, or had it installed at the Dealer, the core must be returned
to the Dealer you purchased it from. Full core rebate is paid to you as long as the core is as
complete as the product provided, missing no parts and returned in the ACDelco box the new part
was received in. Make sure to drain all liquids and place it in a plastic bag to avoid leakage during
the return process. The core return must be received within 6 months of the purchase date of your
new or remanufactured unit.

General Motors offers a Limited Lifetime Warranty on specific service parts sold by GM dealers. GM warrants to the purchaser that it will replace these specific Genuine GM/ACDelco parts for all manufacturer defects including normal wear and use, including 24 months of labor (see list below):

- Chassis Parts
- Fuel Pumps –Electronic
- Ignition Wire Sets

- Radiators
- Shock Absorbers/Struts
- Wheel Bearings –Hub Bearings

**Effective Date:** This Limited Lifetime Warranty is valid for parts purchased on or after April 1, 2014, and shall remain in effect for as long as the named purchaser owns the vehicle on which the part was installed.

**Qualifications:** It will be incumbent on the purchaser to retain the original sales receipt and/ or job card, together with the properly completed warranty reimbursement form. #### 12-MONTH/UNLIMITED WARRANTY

This auto part warranty remains in effect for as long as the original purchaser owns the eligible vehicle on which the part(s) was originally installed. The original purchaser seeking a repair must return the vehicle to a Chevrolet, Buick, GMC, or Cadillac dealership. The original purchaser must provide a copy of the original auto repair order showing that a Chevrolet, Buick, GMC, or Cadillac

dealership had earlier replaced the warranty-eligible part. The cost of the replacement auto part(s) will be covered; labor is covered up to 2 years of original purchased part.
